Eligibility Criteria:

To access the NDIS, you generally need to:

- Be aged under 65 at the time of application
- Be an Australian citizen, permanent resident, or hold a Protected Special Category Visa
- Have a permanent and significant disability that impacts your ability to take part in everyday activities
- Require support now and into the future

Access Request Form:

To apply, you'll need to complete the NDIS Access Request Form:

- **Section 1** – Participant Details: This section captures your personal information, including your identity, contact details, and consent.
- **Section 2** – Supporting Evidence: This is completed by your treating health professional (e.g. GP, specialist, or allied health practitioner). It provides medical evidence about your disability, how it affects your daily life, and the supports you require.

We can assist you in understanding and completing the form to ensure all required information is included.
